CALLS OF INTEREST

Incident # 45-20-02753 Robesonia Borough

On 18 August, 2020, at 5:33 P.M., at 123 S. Robeson Street, Robesonia. A 26-year-old male from Birdsboro violently assaulted his 25-year-old girlfriend that lives at the address after she attempted to end their relationship. The male punched the female with a closed fist on her left eye, bit her on the face, held her down, and put her in a head lock cutting off her breathing. The female was able to break free and run to her Neighbor's house at 117 S. Robeson Street where she was able to call the Police. The male fled the scene on foot as soon as the Police were called but was located by responding Officers at the funeral home at the intersection of Penn Avenue and Old West Penn Avenue and taken into custody.

The male was charged with Strangulation, Simple Assault, Harassment, Possession of marijuana, and drug paraphernalia, and taken for an immediate arraignment at the Berks County Courthouse

Incident # 45-20-02819 Wernersville Borough

On Saturday night, August 22nd around 9:46 P.M. in the area of Penn Avenue and Walnut Street in Wernersville, South Heidelberg Township Officer Bryan Baxter stopped a vehicle for an expired registration, and upon making contact with the 20-year-old driver, he immediately smelled a strong odor of marijuana coming from the car. When questioned about the presence of marijuana in the car, the 21-year-old female passenger stated that she had a medical marijuana card, but when asked, admitted that the marijuana in the car was not part of her medical prescription.

Upon searching the car, Officer Baxter, along with SHPD Corporal Mike Fizz and Officer Marc Oxenford discovered a large amount of marijuana packaged for sale, over 100 pods of THC oil, a container of THC wax, several containers of LSD, a digital scale, packaging material and \$442 in cash.

The items were all seized and will be sent to the Pennsylvania State Police laboratory for analysis. Both women are cooperating and were released at the scene with charges pending upon completion of the lab results (We need to have a correct analysis on the substances to properly charge the correct statute)



One of the women is from Wernersville, the other is from West Lawn.
